1998 SERA WINTER BUJNESS MEETING

The 1998 SERA Winter Business Meeting was held in Huntsville, Alabama, March 21, 1998 and was hosted by the Huntsville Grotto. The meeting was held in conjunction with the NSS Board of Governors meeting.

Morning Session:

The morning session was called to order by Chair Brent Aulenbach. Thirty cavers, reprsenting over 20 organizations within SERA were present and briefed everyone on their activities for the past year. Following the introductions, Butch Feldhaus, Chattanooga Grotto, presented a slide presentation on the NCRC training program.

Afternoon Business Meeting:

After calling the meeting to order, Chair Brent Aulenbach did a roll call of all grottos and organizations present. Twenty-three organizations, representing grottos, surveys and project groups, answered the call.

The minutes to last years meeting were approved without any changes.

Next, Michael Gilbert, Chair of the Central Alabama Grotto, presented a summary of the 1997 SERA Summer Cave Carnival. Among the facts presented were: 742 t-shirts were printed, including 642 for attendees; the SpeleoSpa, rented from the TAG Spa Association, was worth the rental; the band played on into the night, despite the rain; the fireworks were a big hit; and thanks to Raccoon Mtn. Caverns for keeping the campgorund open for those involved in the McBrides rescue.

1998 SERA Summer Cave Carnival Chair John Hoffelt then gave a presentation on the upcoming 47th Annual SERA Summer Cave Carnival, to be held at Cordell Hull Lake, near Smithfield, TN. There will be a guidebook with directions and a number of led trips; the Spa Association will be providing the Spa again; there will be a vertical contest, a munchie stand and a continuous slide show after dusk. Gerald Moni is in charge of registration. Chuck Manglesdorf took the floor and said there would be a equipment and techniques seminar on Saturday morning where distributors, manufacturere and vendors could

demonstrate their products.

Following these presentations. Chair Aulenbach visited the order of first refusal for the next WBM and the Lost Mountain Cavers, next on the list, indicated that they would be hosting the 1999 WBM in the Atlanta. GA area, date to be announced.

Executive Reports:

Chair Aulenbach welcomed everyone and presented the treasurers report for last year. Vice-Chair Hunter spoke as the editor of the SERA Newsletter. He expressed appreciation to those that responded to his earlier request on TagNet for material and told everyone to be looking for more request this summer. Chair Aulenbach indicated that he was glad we were back on track with the newsletter and that he had little more to say.

Old Business:

The floor was opened to discuss old business. The only old business discussed was April Oberling's Scotts Gulf project. April was not in attendance but she did send a message to be read to the group. Basically, the project is on hold at this time while sensitive negotiations continue among all parties involved. She asked that all refrain from public criticism of Bridgestone at this time while issues remain to be resolved.

New Business:

Roger Haley, Huntsville Grotto, thanked everyone for coming and provided details for the pre-Convention camp that the Huntsville Grotto is sponsoring. It will be limited to 80 people and all proceeds will go to the SCCI. Volunteer trip leaders will get in free.

Bill Stringfellow, representing the DCG Fall Tag Cave-In Advisory Board, briefed everyone on new rules for this years Cave-In. These include: absolutely no dogs: no ATVs, no open fires in the field camping areas; and primary registrants must be NSS members and can have up to four guest per primary registrant.

Brent Aulenbach pointed out that there was no photo salon this year, mainly because last years organizer.

Marion Ziemons, was not around this year to do it. He asked for a volunteer to take over the task for next year and Dan Barnick agreed to either find someone or do it himself.

Jim Wilbanks, Chattanooga Grotto, discussed the property boundary survey for the SCCI Fox Mountain Preserve and asked for volunteers to help on upcoming weekends.

Roger Haley, Huntsville Grotto, took the floor and brought up the subject of the upcoming CaveStock event at Smokey Caldwell's farm in Lafayette, GA. After much discussion, with input from Brent Aulenbach, Gerald Moni, William Shrewsbury, Jim Wilbanks, Richard Blackburn (who stated unequivocally that the Lost Mountain Cavers did not endorse the event). Scott Fee, Bill Stringfellow, Helen Galloway, Cecile James, Mike??, Kenneth Huffines, Dan Barnick and Marie (Clair?), it was decided, by a near unanimous vote (all in favor except for one against and one abstaining) that SERA issue an official statement regarding the event. After discussion on the wording the following statement was approved:

"The Southeastern Regional Association does not endorse the event to be held in April known as Cave Stock."

Don Hunter agreed to desimminate this statement via TagNet and Caver's Digest.

Jim Wilbanks, Chattanoooga Grotto, made a motion that SERA purchase an acre of the Fox Mountain Preserve. This motion was passed.

Scott Fee took the floor to bring up the issue of the starter for Roy Whites car. It was indicated by several in attendance that enough money had been collected to buy the starter and have extra money and that the starter was on its way and would be installed by the end of the weekend. The motion was tabled.

Bill Bussey took the floor and asked if it would be appropriate to establish a discretionary fund to handle issues such at Roy White's starter in the future. John Hoffelt took the floor and suggested that these kinds of things should be handled locally. The matter was tabled.

Elections:

John Hoffelt nominated Dan Barnick for Vice-Chair. Gerald Moni nominated Rob Robbins, who declined. Dan Barnick was elected as the Vice-Chair for next vear.

Bill Bussey was once again elected as Secretary/Treasurer.

Last Minute Statements:

Bill Putnam thanked everyone for their support of SCCI and Bill Bussey reminded everyone to get copies of the "Guide To Responsible Caving" before leaving.

HIJORICAL BACKGROUND OF THE FRANCIS MCKINNEY AWARD OF THE SOUTHEAJTERN REGIONAL ASSOCIATION OF THE NATIONAL SPELEOLOGICAL SOCIETY

Although this award has been presented for only 21 years as of the writing of this article, the spelean historian can appreciate the fact that it is necessary to document the events and background for the formation of this solemn and prestigeous award as part of our caving history. The purpose of this short article is to document for posterity the formation of this event. It is not my intent to present the criterion for the award. That information can be obtained from the current elected officers of the Southeastern Regional Association.

Some Background on Francis E. McKinney - The Person

As recorded in Francis' obituary, he was "an ebullient and hard-working caver. Francis joined the Society (National Speleogical) in 1958 and was made Fellow in 1971. While attending Auburn (University), and working in Huntsville (Alabama), he caved extensively in Alabama, being the second person down Fern (July 9, 1961). In recent years he caved primarily in East Tennessee and Puerto Rico. As an active caver over a long period of time Francis held numerous grotto and regional offices and served as an editor for the Bulletin."

Francis was very active in the Oakridge Community Playhouse. He had received the Gold Pin honor from the Auburn Players. He wrote and directed plays. In September, 1962 he opened the regular season at the Rocket City, Huntsville Little Theatre with "Desk Set" directed by himself. He also served on the playhouse board of directors.

Francis graduated from Auburn on June 1, 1962 with a BS in math and went to work for NASA's Marshall Space Flight Center working in the aeroballistic laboratory in the aerodynamics analysis branch. While

at Auburn he belonged to a friendship type of club called the "First Hundred." In this organization Francis and other members kept in touch with a series of letters circulating among themselves.

By the summer of 1962 Francis had completed five years of caving. He had just participated in two expeditions to Fern Cave, Alabama. Fern's 426-foot measured depth was the nation's deepest shaft at that time. He acted as the leader of the second trip to the cave.

Francis made four trips to cave the Rio Camuy System of Puerto Rico to map and explore. On March 26, 1975 Francis fell about 75 feet to his death while exiting the Ventosa entrance passageway located near Bayaney. He died at about 9:35 PM from a rupture of the aorta. His accident was caused, it is thought, from the failure of an upper Jumar sling made of low abrasion resistant polypropylene ski rope.

Thus one of SERA's and TAG's most active and enthusiastic cavers passed into history.

Idea for an Award and its Formation

After the death of Francis there was a series of letters sent back and forth among the various grottos of SERA and the SERA officers as well. It had been suggested at the 1975 SERA Cave Carnival in Monterey, Tennessee, that the region memorialize Francis by (continued on next page)

presenting the "SERA Francis McKinney Award." During the SERA Winter Business Meeting, held in Huntsville on February 7, 1976, this suggestion was voted on and passed by a vote of the attending grottos. In SERA each attending internal organization has an equal vote in all business no matter how large or how small their membership may be.

The Award was to be similar in spirit tot he Lew Bicking Award and was to be given at the Summer Cave Carnival, however, the presentation location was quickly changed to the banquet held yearly during the Winter Business Meeting. This meeting is hosted by a different internal organization and is held in a different area in the southeast each winter, usually in February. It was felt that it would be a more befitting occasion to present the award in such a surrounding as opposed to a more "party type" atmosphere.

The award was the first merit award presented by the Region. There is a plaque located in the NSS headquarters in Huntsville, upon which the name of each recipient is engraved.

GROTTO HIGHLIGHT

Southport Chronic Cavers, The Work at Hubbards Cave Continues - 1998

(Editors Note: In 1997, the Southport Chronic Cavers organized a tremendously successful clean-up of Hubbards Cave, Warren County, Tennessee. The cave is a historically significant cave, with old saltpeter works and remnant artifacts and many old signatures. It was obvious during the 1997 clean-up that the cave was the victim of ongoing vandalism and that something needed to be done to both repair this vandalism and curtail it in the future. The following describes the work that continued, during 1998, in the cave.)

There were four major preservation trips into Hubbards Cave in 1998. Participating on these memorable and enlightening trips were:Bob Currie (USFWS), Jim Kennedy (BCI), Dr. Jan Simek (UTK), Gabby Call, David Campbell and Beth Guidera (TNC). Joe Douglas and Thany Mann (Nashville Grotto). Brian and Lynn Roebuck, Marbry Hardin and Daniel Wright (Tennessee Central Basin Grotto). April and Anthony Olberding (Upper Cumberland Grotto), Kris Beckwith, Keaton Kell, Tim Curtis, Dallas Sullivan. Steve and Rosemarie MacDonell (Spencer Mountain Grotto), Jim Hodson (Caretaker of Blowhole Cave), Buddy Baldwin, Mark Dunnavant and Rob Robbins (Southport Chronic Cavers), Paul Bowen, Dawn and Benjy Von Cramon, Alan Cressler, Joanne Bennett and a host of others.

Three of the four major trips were documentation trips, conducted in an attempt to document every signature in the cave and to search out possible evidence of early mining. During one of the early trips in 1998, exposed wooden water troughs in the entrance hole were


reburied to help preserve them from exposure. To date, we are far from finished and much work remains to be done. We expect to make many additional trips into the cave to complete this part of the survey in the months to come, as soon as the cave is re-opened after the bats have left.

The June trips were for the purpose of gating the west entrance. The project was completed in the record time of two days. Much muscle was provided by many of the above named and their time and support was certainly appreciated. The gate was necessitated by the constant destruction of artifacts by vandals.

Joe Douglas is keeping the records of all the signatures and is compiling quite a list. Dr. Simek is studying the cave for evidence of early (Middle Woodland period) gypsum mining. Several cane torches have been removed for further scientific study. Findings and reports of these activites will be made available at a later date.

1999 will prove to be another busy year at Hubbards Cave. Upcoming is another gating project, which will be announced at a later date. Of course, your help in this project will be appreciated. We also hope to re-map the cave, identifying the exact locations of several important features not listed on the current map. Hopefully this will be a combined effort of many grottos.

As is my belief, the joint efforts of all the various involved grottos only serves to make us a much stronger organization, all working together for a common goal. How else are we going to preserve what we have? We all can learn from each other.

Campaign Area Caving Association

"Twixt the Collins and Rocky Rivers...'neath the pocked plain... the Campaign underground beckons."

CACA, the Campaign Area Caving Association, is a group of cavers dedicated to the mapping and exploration of the caves of the Campaign, Tennessee area. The group, founded by Don Hunter, is comprised of a number of people who have, for the past four years, have been involved in mapping the caves found beneath the Campaign sinkhole plains.

The inception for this project group begain in the summer of 1995 following a dye trace conducted by Don Hunter and Jim Smith in the Campaign area. After the dye trace, it became evident that the many caves in the area, though turned in to the TCS, were not mapped. Thus began the slow and methodical surveying and mapping of the caves. The summer of 1995 found CACA cavers in Miller's Cave, on the farm of Bill Walter, beginning the first survey. In the years following, they gradually moved on to Invisible Cave, York Cave, Cable Cave, Turkey Scratch Cave, Hazel

Ward Cave, Jaco Springs Cave, Larkin Slough Cave and Glow Worm Cave.

At this time, approximately 3.5 miles have been mapped in these caves. Jaco Springs, at over 4,000 feet, is the longest. Several are in the 2,000 to 3,000 foot range. Although the surveys have added much length to the reported lengths of several of the caves, it is Glow Worm Cave that has grown the most. Turned in at about 150 feet, Glow Worm now stands at over a half a mile.

Glow Worm has also provided the most exitement for CACA participants. In May of 1997, five members found themselves trapped for almost 19 hours due to rising waters following an intense and prolonged line of showers, which passed over the area immediately after they entered the cave.

1999 should find all of the currently known caves in the Campaign area mapped, completing what could be considered the first phase of a multi-phase project. An article for the Tennessee Cave Survey is anticipated, documenting the past four years efforts. Next, an effort to turn up more caves in the area. Several leads have already developed that show much promise. For example, the upstream drainage of the Hazel Ward/Jaco Springs "system". A possible cave has already been reported for this area, which should, by all reason, yield a significant extension. There should be much to keep us coming back to the area for years, providing many more opportunities to terrorize the waiters in the local Mexican restuarants with our very special "CACA" t-shirts.

YELL CAVE FENCING

On March 23, 1997, while in Bedford County effecting a normal survey of Yell Cave (if there is such a thing), members of HR3 (pronounced HR cubed), a survey faction of the Tennessee Central Basin Grotto based out of Murfreesboro, TN, made a startling discovery. During the course of the survey on that day, they discovered what they believed were gray bats, a species on the Federal Endangered Species list.

Contact was immediately made with TDFC. TNC, USFWS, TWRA and TVA to get some assistance in identifying these bats. In June of 1997, David Withers (TDFC), T. Hill Henry (TVA), Bob Currie (USFWS), Beth Guidera (TNC), John Lamb and Brian and Lynn Roebuck (HR3) met at Yell Cave for the purpose of a preliminary bat emergence count and further study. The results were startling. Yell Cave was a maternity colony cave with a significant population of gray bats (myotis grisescens) and it was obvious that something should be done to further protect them.

The owners of Yell Cave, who had always been very cooperative with the members of the Tennessee Central Basin Grotto, were contacted by representatives of The Nature Conservancy and HR3. A management plan was developed and signed by all parties involved. Steps were taken to begin planning for a gate to be installed to prevent entry during the crucial time when the cave was occupied by the maternity colony. Next, a study was conducted to determine the best way to protect this cave. After observing the entering and exiting patterns of the bats, it was decided that a fence around the perimeter of the cave entrance would probably serve the purpose much better than an actual gate, as the bats, especially maternity colonies, do not like gates.

So, on three consecutive Saturdays beginning on September 21st, 1998, the following people had a part in the erection of the fence at Yell Cave:

Gabby Call, Beth Guidera, Tara Thompson, and Chris Roberts (all of The Nature Conservancy). Brian and Lynn Roebuck, Karen Karr, Drew Irwin, David Yoest, Marbry Hardin, Don Cole, David Cole, Ray Pope, Ray Pope Sr., Jeremy "Bat Bubba" Hill, Daniel Wright.



Robert Brazier, James Taylor, John and Debbie Hettish, Connie Ramsey and Rob Robbins.

Materials had to be carried in on the back of the peopules (people acting as mules), often requiring teamwork with the large bulky items. Many people got to try the jack-hammer out making the post holes. Brian Roebuck's Bronco suffered the most damage, bottoming out on a rock and destroying the bottom of the transfer case. There goes our \$500 damage rule.

The owners were so thankful for the effort that on each construction day, not only did they bring liquid refreshment to the workers, they also had a nice barbecue for them afterwards. It is only through these cooperative efforts, with all agencies involved, can we even begin to conserve what we have. Another job WELL DONE!
